



10. The information about the staff has been verified from the original records submitted by the candidates and found correct.

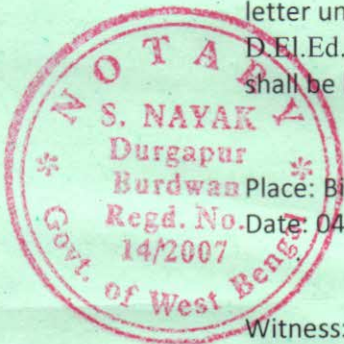




